I am writing to you in connection with your Advanced Disposal Services Glacier Ridge Landfill Negotiated Agreement, dated as of January 1, 2013 (the "Agreement"), with Advanced Disposal Services Glacier Ridge Landfill, LLC ("Glacier Ridge Landfill").

Effective as of October 30, 2020, GFL Everglades Holdings, LLC acquired all of the equity interest in Advanced Disposal Services Glacier Ridge Landfill, LLC, whereby Advanced Disposal Services Glacier Ridge Landfill, LLC became a wholly owned subsidiary of GFL. Shortly thereafter, Advanced Disposal Services Glacier Ridge Landfill, LLC filed Articles of Amendment to its Articles of Organization changing its name to Glacier Ridge Landfill, LLC effective December 4, 2020. Enclosed is a copy of the name change as filed with the Wisconsin Department of Financial Institutions. Accordingly, Glacier Landfill, LLC will continue to own and perform all obligations under the Agreement to the same
