WHEREAS, the Plan Commission of the Village of Kekoskee, Dodge County, Wisconsin, by this resolution, adopted by a majority of the Plan Commission on a roll call vote with a quorum present and voting and proper notice having been given, resolves and orders as follows:

That the Village of Kekoskee Plan Commission hereby recommends that the Recommended Comprehensive Plan and plan adoption ordinance are filed with the governmental units specified under section 66.1001(4)(b) and (c), and will be discussed at a public hearing required under section 66.1001(4)(d) as provided in accordance with the following Notice of Hearing, which the village clerk shall publish by a class 1 notice under chapter 985, Wis. stats.:

Notice of Hearing – Village of Kekoskee Comprehensive Plan

- A. A public hearing to discuss the Recommended Village of Kekoskee Comprehensive Plan and the adoption of an ordinance to adopt the comprehensive plan shall be held at the Village Hall on August 30, 2022 at 5:30 p.m.
 - B. The Recommended Comprehensive Plan in summary contains the following elements: Issues and Opportunities; Housing; Transportation; Utilities and Community Facilities; Agricultural, Natural, and Cultural Resources; Economic Development; Intergovernmental Cooperation; Land Use; Implementation.
 - C. The public may review copies of the Recommended Comprehensive Plan on the Village’s website, Kekoskee.com and submit WRITTEN comments/questions. The public may also submit written questions/comments to the Clerk at W3275 County Road TW, Mayville, WI 53050 until the conclusion of the Public Hearing. The Village will respond in writing to those comments/questions if requested to do so. The Clerk can also provide additional information on the recommended comprehensive plan and adoption ordinance.


BE IT FURTHER RESOLVED, that upon close of the Public Hearing, comments will be forwarded to the Village Board for consideration.

BE IT FURTHER RESOLVED, that possible action on adoption of the Recommended Comprehensive Plan by ordinance will take place at the Village Board’s meeting.


